- a. the candidate must be a member, citizen or enrollee of a Nuuchah-nulth First Nation (refer to #2 above);
- b. the candidate must be nominated in writing and supported by the signatures of a minimum of 20 persons who are sixteen years or older and who are members, citizens, or enrollees of a Nuuchah-nulth First Nation (refer to #8 in following pages);
- c. the candidate must provide a completed application form demonstrating the following qualifications:

i. Completion of a Diploma or Degree in a related field is an asset but not required.	
ii. Experience in areas of FN culture, traditions and governance	
iii. Knowledge of NCN issues	
iv. Experience in lobbying & negotiating

vi. Experience in dealing with media relations	
vii. Experience in budget and contract development	
viii. Proof of NCN membership	
ix. Current Drivers Licence (please include copy with application)	
x. Must provide current (within 2 years) criminal record check	
xi. Must demonstrate excellent oral and written communications abilities	

xii. Basic computer literacy	
xiii. Strategic and analytical thinking and problem solving	
xiv. Experience in conflict resolution	

Please ensure this application is legible. Illegible applications may be disqualified during the screening process.

If all documentation is not received with the nomination package – the application may be disqualified.
